Summary of Events

Criminal Mischief

19000 E Challe Cir – Complainant reported approximately \$100 dollars worth of damage to her vehicle which was caused by an unknown suspect(s).

Transportation Code Violation:

600 E Cypresswood Dr- A traffic stop was conducted for transportation code violation. The driver was found to have no driver's license and no insurance. The vehicle was towed and citations were issued.

700 E Cypresswood Dr- A traffic stop was conducted for transportation code violation. The driver was found have an open warrant. The driver was taken into custody for the warrant and booked into the Harris County Jail.

Minor Accident:

700 E Cypresswood – A 2 vehicle accident was reported. All drivers were able to leave the scene without injuries. The at fault driver was issued a citation.

700 E Cypresswood – A 1 vehicle accident was reported. The driver requested a report for documentation purposes. There were no major injuries.

ALARMS - Contract patrol deputies responded to 4 local alarms at various locations within the

community. They were handled without incident and were all found to be false alarms.

MUD CHECKS – Contract patrol deputies made 38 Municipal Utility Checks within the community. There were no signs of foul play and all facilities appeared to be in good working order.

OTHER CALLS - Contract and District patrol deputies responded to 40 other calls for service within the community, while maintaining peace and justice in the contracts.

SUSPICIOUS ACTIVITY – Contract patrol deputies responded to 5 suspicious vehicles and 3 suspicious person within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.

TRAFFIC – Contract patrol deputies made 62 traffic stops, enforcing the traffic laws of the state of Texas, within the contract reducing the possibility of accidents and lessening the chance of repeat offenders in the patrolled areas.
