#### Summary of Events

##### September Stats

##### Burglary of a Habitation:

1000 Lynwood Rd– Complainant reported that an unknown suspect(s) forced entry into the complaints residence and stole property.

##### Burglary of a Motor Vehicle:

200 Allis St- Report was made in contract but the incident occurred outside of the contract. The complainant reported that an unknown suspect(s) made unauthorized entry into the complaint's vehicle and took property.

##### Theft:

600 Ringwood – A Male suspect took items from the complaint's porch without authorization.  
19500 Barwick Dr – An unknown suspect(s) stole items from the complaint's vehicle without authorization.

##### Fraudulent Use of ID:

19300 Whitewood Dr- Complainant reported that an unknown suspect(s) had made unauthorized credit card transactions.

##### Drug Possession:

600 E Cypresswood Dr- A traffic stop led to the driver being found in possession of marijuana. The Harris County District Attorney's Office was contacted and advised to place the male into the misdemeanor marijuana diversion program. The vehicle was towed due the traffic violations and the driver was released.

Family Disturbance:

600 E Cypresswood Dr- Two known family members were involved in a verbal disturbance. No criminal offense occurred. The parties were separated without incident.

Accidents:

200 E North Hill- An unknown subject crashed a vehicle into the ditch at the above address and then fled the scene on the foot. The registered owner of the vehicle advised that the vehicle had been lent to an friend who deputies were unable to identify at this time. The vehicle was returned to the registered owner.

600 E Cypresswood Dr- Deputies were patrolling when they located a minor accident. There was no injuries and no damages. The parties did not want a police report so a crash non investigation form was signed.

ALARMS – Contract patrol deputies responded to 4 local alarms at various locations within the community. They were handled without incident and were all found to be false alarms.

MUD CHECKS – Contract patrol deputies made 56 Municipal Utility Checks within the community. There were no signs of foul play and all facilities appeared to be in good working order.

OTHER CALLS - Contract and District patrol deputies responded 49 to other calls for service within the community, while maintaining peace and justice in the contracts.

SUSPICIOUS VEHICLES – Contract patrol deputies responded to 4 suspicious vehicles within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.
