Summary of Events

Assault Family

700 block of E Cypresswood Dr -Evening shift- The complainant stated that she was assaulted by her boyfriend/suspect during a verbal argument. Nuisance Abatement

MUD Checks

Contract Patrol Deputies made 26 Municipal Utility checks within the community. There were no signs of foul play and all the facilities appeared to be in good working order.
