- 2. Qualified Applicants may give a three (3) minute presentation to the board at subsequent regular or special meeting.
 - a. Order of presentations will be based on date/time the qualification affidavit is received by the District Attorney.

The deadline for accepting qualification applications from the Qualified Persons is <u>5:00</u> pm on <u>Tuesday</u>, <u>April 1, 2025</u>.

Oral presentations will be tentatively scheduled for the Tuesday, April 15, 2025, Board Meeting and will occur prior to the Public Comment agenda item. Note: A special Directors Meeting may be called to hear oral presentations.

Appointment Process by Directors:

The appointment process by the Directors will begin at the Tuesday, May 20, 2025, Board Meeting, unless a special meeting is called prior to or after the Tuesday, Tuesday, May 20, 2025 Meeting. The Directors retain the ability to recommend to the Board any Qualified Person during the appointment process. A Director may nominate an appointment from qualified applicants or someone of his own choosing whom the Director has qualified. The nomination will require a second before the nomination can be considered by the Directors.

The State of Texas requires the Directors to appoint a Director within sixty (60) days of a vacancy. The TCEQ may appoint a person to fill the vacancy if the vacancy continues longer than ninety (90) days. The appointed director's term shall be for the unexpired term, which concludes May 2026.
